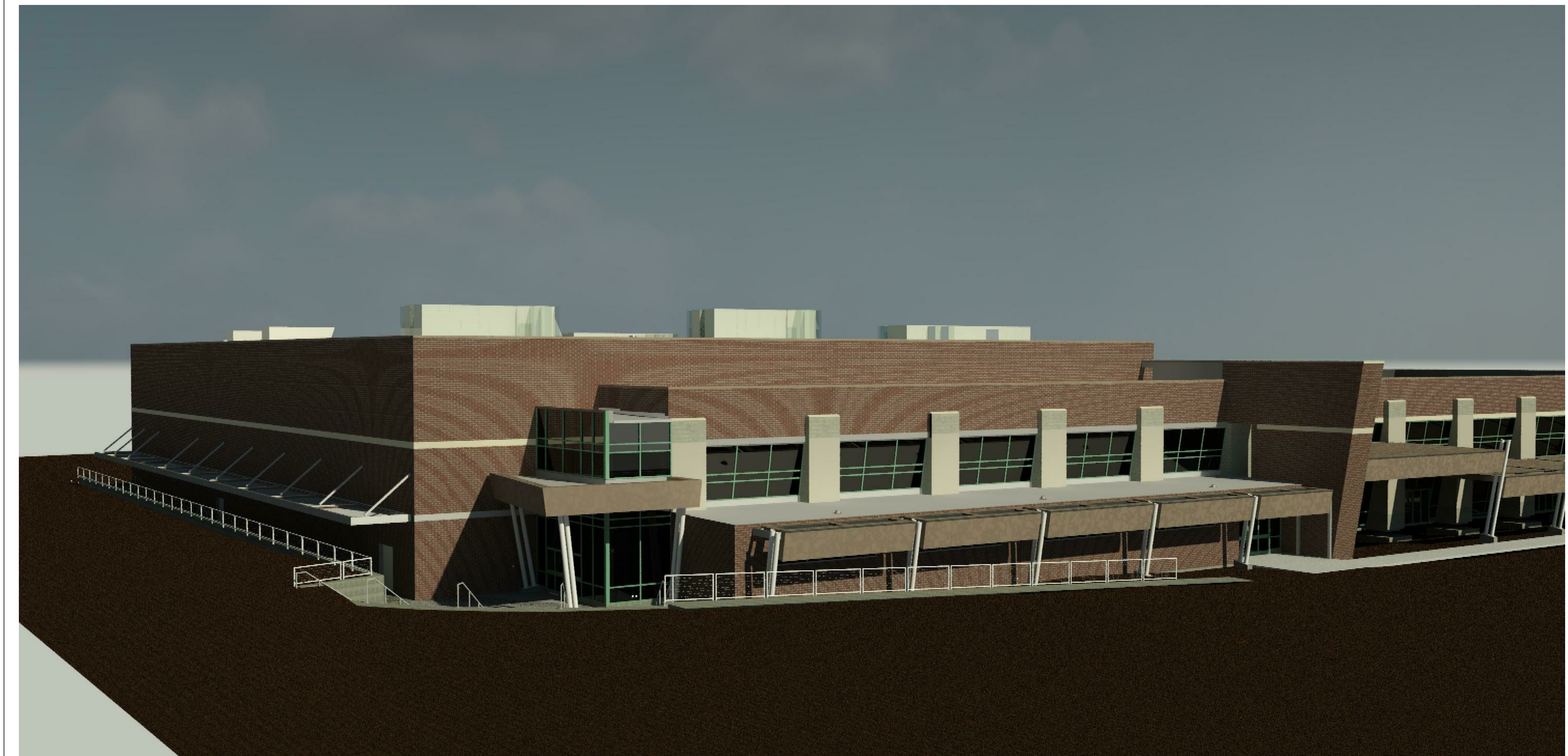

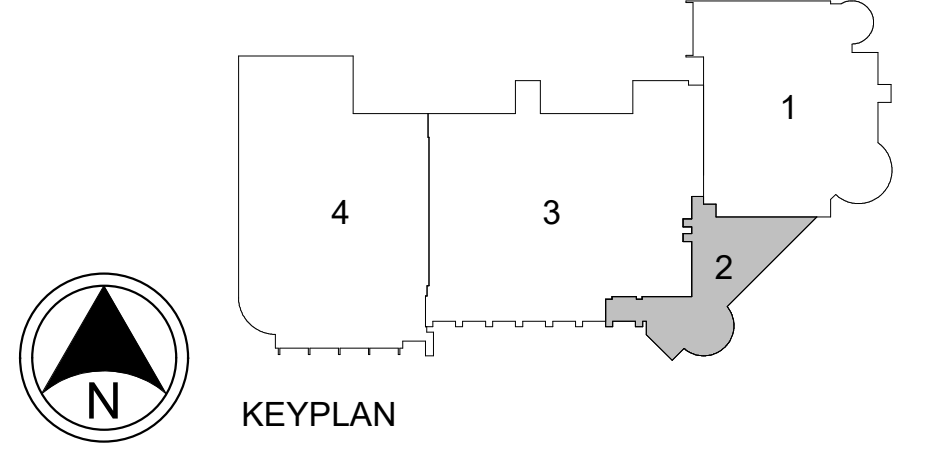
FLOOR PLAN - FIRST LEVEL - 1

FFE FLOOR PLAN - SECOND LEVEL - AREA 4B

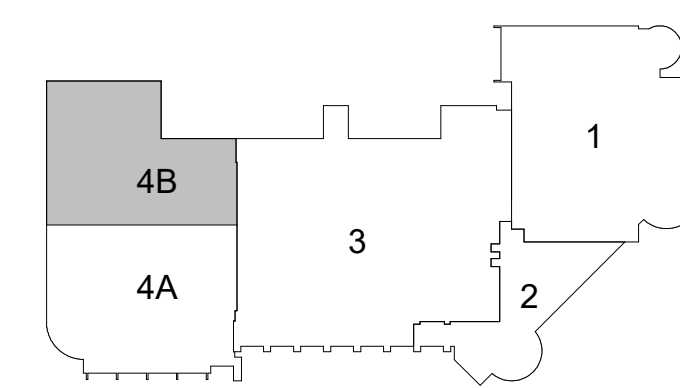
